Dear Parent/Carer,

I write to provide an update on the coronavirus and advice to schools. All schools in the Trust continue to follow government advice in managing the coronavirus. You will be aware that current government guidelines are that schools should remain open. Please understand that the government provides daily advice to schools and as you would expect, we have been strictly following this. Please be assured that the School will update parents and carers of any changes, and in these uncertain times we can only communicate as and when we know more information.

Public Health England have announced new guidance for people with confirmed or possible infection. This means that those with a new continuous cough and/or high temperature should not leave their house for 7 days from when the symptoms started. This is in addition to the 14 day self-isolation for anyone who has had close contact with a confirmed case but has not shown symptoms. If your child develops such symptoms and needs to remain at home then please let us know and keep us updated. The current government advice is that other people in your household who have had close contact do not need to self-isolate.

The guidance for helping prevent the spread of infection (of coronavirus and other viruses) includes a strong focus on hygiene:

- Washing hands with soap and hot water for 20 seconds at regular points during the day.
- If you need to cough or sneeze: Catch it with a tissues, Bin it and Kill it by washing your hands.

Please reinforce these key messages at home just as we are doing in school.

Obviously, these prevention measures have led to a significant increase on the hand washing facilities in school. Monitoring checks of these facilities have been increased across the School but if a pupil discovers a soap dispenser which is empty or broken we would encourage them to report it to a member of staff so that this can be rectified promptly as we recognise these facilities are a key part of the prevention measures.

The Department for Education update to schools included the following information with regards to the forthcoming exam series:

"We recognise that students, parents, schools and colleges will be concerned about the possible impact of coronavirus on the 2020 summer exam series. Ofqual's advice currently is to continue to prepare for exams and other assessments as normal. Ofqual continues to work closely with exam boards, other regulators and the Department for Education to plan for a range of scenarios, as the public would expect. Our overriding priorities are fairness to students this summer and keeping disruption to a minimum. It is still many weeks until exams start and we will issue updated advice if necessary, giving schools and colleges as much notice as possible."

Please note that Trust and school leaders have been working on contingency plans in the event of any school closures.

Please ensure that you stay familiar with, and follow, the current advice provided by Public Health England.
